



COASTAL MACHINERY – Terms & Conditions

*****Purchaser must check all wheel nuts between the first 50 – 100kms*****

One (1) Year Frame Warranty

COASTAL MACHINERY warrants that each trailer and its fabricated steel components, including the ball coupling to be free of structural or warranty defects for a period of one year from the date of original purchase date. Tyres and tubes are excluded.

3 – Month Warranty

COASTAL MACHINERY warrants that the trailer LED lighting, U bolts, nuts, bolts, mechanical/electrical braking equipment, axles, wheel bearings, seals and all other wear parts for a period of 3 months from the original purchase date.

OBLIGATION – COASTAL MACHINERY shall repair or replace within reasonable time any item covered under the warranties above by methods or solutions decided by COASTAL MACHINERY staff. All warranty claims need prior authorisation by COASTAL MACHINERY. COASTAL MACHINERY is under no obligation to collect trailer, or repair trailer off site.

In ALL cases the owner must pay the cost of transporting the COASTMAC trailer, to and from the factory. Freight and delivery costs are not included in the warranty claims, and will be paid by the owner.

CONDITIONS - Satisfactory proof of purchase must be given at the date of notification of any claims under warranty. This warranty is limited to structural defects in workmanship performed only by COASTAL MACHINERY. Notification of any warranty issue must be given to COASTAL MACHINERY within 24hrs of the issue occurring. COASTAL MACHINERY must be given access to inspect the trailer at its factory at 10 – 12 South Western Hwy, Picton WA 6229. The trailer must not be used to carry a load until inspection is completed. Unless otherwise directed by COASTAL MACHINERY all warranty repairs are to be completed by COASTAL MACHINERY, at its address in Picton, WA. Any work carried out on a COASTMAC trailer except by COASTAL MACHINERY/and or its authorised Agent, without prior approval from Coastal Machinery Pty Ltd will void this warranty. This warranty is valid to the original purchaser only and is not transferable to a third party.

NOT COVERED - This warranty is limited to exclude any claim relating to:

1. Tyres.
2. Jockey wheel.
3. Misuse of the COASTMAC trailer including but not limited to using the trailer with a load in excess of its structural capacity as designated on the compliance plate attached to the trailer.
4. Incidental and consequential damages or costs of any kind.
5. Failure to maintain the COASTMAC trailer.
6. Rust occurring on the COASTMAC trailer or any of its components e.g. axles, springs, couplings and/or jockey wheel.
7. Any component fitted by COASTAL MACHINERY that was not manufactured by COASTAL MACHINERY (including but not limited to electric winches and hydraulic systems) that items are covered by the original manufacturer's warranty and must be used in accordance with the original manufacturers guidelines.
8. The cosmetic appearance of the trailer including but not limited to galvanised surfaces and the paint becoming dull or faded.
9. Damage caused by alterations or modifications, fair wear and tear, accidents or off road use.

COASTAL MACHINERY recommends that your trailer be serviced at least once a year, with brakes and bearings requiring six monthly service attention. Checks should be done on all your running gear regularly. Regular maintenance will lengthen the life of the trailer and keep the trailer in safe working operation.
